Dear Governor Wolf,

We applaud you for fighting against the Trump Administration's attack on clean car and fuel economy standards and for fighting for your citizens' pocketbooks and lungs. We urge you to take a bold step by holding nine automakers<sup>1</sup> accountable for supporting President Trump's attack on states' rights and the Clean Air Act. The rollback and freeze of the widely popular fuel economy standards hurts Pennsylvanian consumers, automakers, and the climate alike. We also urge you to send a message to these automakers by refusing to spend your citizens' tax dollars on their products.

As you are well aware, last September the U.S. Environmental Protection Agency (EPA) issued a final rule to revoke Section 177 of the Clean Air Act, which allows states to adopt a stronger tailpipe emissions standard. This rule is now in the courts, with your state and 23 others fighting for the right to safeguard your citizens' well-being. We were very disappointed that nine automakers have sided with the Trump Administration in the lawsuit and have taken the position that this right, guaranteed by the Clean Air Act, which has enjoyed bi-partisan support for more than 40 years, should be stripped from the law.

Consumer Federation of America, Consumer Action, and Consumers for Auto Reliability and Safety believe that by boycotting these nine automakers from state fleet purchases you can send a signal and show them that you do not condone the fact that they are actively working to roll back progress on the climate crisis and air pollution. Ultimately, this pressure will help

motivate them to abandon their support of the Trump Administration's anti-consumer, anti-environmental position.

Our organizations supported the original national clean car standards, and strongly believe that these companies have chosen the wrong path forward. We urge you to put your state's taxpayer dollars toward vehicles made by automakers that support clean car standards by fighting the climate crisis, reducing air pollution, and saving Pennsylvanian consumers money at the pump. In the likely event the administration finalizes its rollback of these vital consumer and public health protections, it will cost Pennsylvania \$10.5 billion<sup>2</sup> in lost fuel savings. Those are crucial savings that should be put back into the local economy.


