Dear Chair Khan:

The following comments regarding the *Rytr LLC* settlement (Docket – FTC-2024-0041) are submitted by the **Consumer Federation of America (CFA), Electronic Privacy Information Center (EPIC),** and the **National Consumers League (NCL)**.

We write in support of the Commission's enforcement action and Complaint filed against Rytr and urge the Commission to proceed with a consent order that includes stronger safeguards against Rytr's ability to commit or facilitate unfair and deceptive conduct through its generative AI technology.

First, we applaud the Federal Trade Commission (FTC or Commission) for holding Rytr responsible for its system that allowed individuals to quickly and easily generate unlimited review content that was likely to be used for illicit purposes. Trustworthy user reviews are a critical component of modern commerce as millions of consumers rely on reviews to inform billions of dollars in purchases from both online and offline businesses. It is difficult—if not impossible—for consumers to accurately judge the quality of goods and services advertised or sold online without the confidence that reviews are genuine. False reviews are also an expensive problem for consumers. A 2021 report found that fraudulent reviews cost consumers an estimated \$152 billion globally.¹ Another study found that by deceiving buyers into purchasing lower quality and potentially unsafe products, fake reviews lead to \$0.12 of consumer welfare lost for every \$1 spent online.² The Commission recently calculated that, based on an estimated \$0.12 loss for every \$1 spent online, combating fake reviews can result in annual benefits to American consumers ranging from \$6.64 billion to \$17.52 billion.³

Second, we urge the Commission to seek stronger and more specific remedies in this matter and future enforcement actions with a similar fact pattern. Products reliant on generative AI

throughout the market allow for this type of behavior at scale. It is critical, then, to ensure that the Commission builds on its Rytr enforcement action to more fully protect consumers amid the rapid proliferation of free generative AI tools. The unchecked spread of generative AI systems also underscores the need for more comprehensive remedies that will meaningfully curb the use of such tools for unfair, deceptive, or otherwise unlawful ends.

I. The Complaint Sufficiently Alleges that Rytr Violated the FTC Act.

We agree with the Commission that the enforcement action and consent order against Rytr for furnishing its users with the means and instrumentalities to engage in deceptive conduct, and for engaging in unfair conduct, should proceed. We respectfully disagree with the views expressed by Commissioners Holyoak and Ferguson in their dissents.

The undersigned groups have supported the Commission's efforts to regulate entities that provide the means and instrumentalities to commit unfair and deceptive conduct.⁴ The FTC has long established, and courts have long upheld, the FTC's ability to seek redress under Section 5 not only from those who directly defraud consumers but also from companies that knew or should have known that they were providing means and instrumentalities to enable such fraud, if the resulting consumer injury was a predictable consequence of the company's actions.⁵ As the Rytr Complaint details, one of the stated purposes of Rytr's product was to generate details and information that were not provided by the actual user of the product. By design, Rytr purposely enabled users to create unfounded product reviews.

Paragraph 12 illustrates the use case at issue in the Complaint. It refers to a user asking for a review of a roofing company, where the user input "called them for roof inspection." In response to this five word prompt, Rytr:

- (1) **created** a background of the user ("I am a roofer by trade"),
- (2) **created** a narrative stating that this user had tried other roofers ("I have used many other roofing services in the past"),
- (3) **created a story** that the user intended to employ this company in the future ("this one is good enough to keep me as a client of theirs"),
- (4) **generated an opinion** about their prices, complete with a typo ("they're [sic] prices are really good"); and
- (5) **created commentary** about the personality traits of their employees ("their personnel is really friendly")

In this way, Rytr's conduct is arguably more egregious than other FTC actions against companies for assisting or facilitating misconduct.⁶ Rytr was not acting as a mere conduit of underlying deception or unfairness: Rytr **created** the technology to, and did in fact **generate**, thousands of fake reviews. While there may be consumers who wish to use generative AI technology to assist with writing a more articulate review of a product, the scalability and demonstrated use of the Testimonial and Review use case make clear that this was not what Rytr intended with its product.

The Commission is right—and on firm legal footing—in taking action against Rytr directly rather than bringing numerous individual enforcement actions against each user who published each of the thousands of fake reviews that Rytr created for them. When the Commission has uncovered evidence about technology to generate volumes of fake reviews that have no legitimate purpose, it is both reasonable and more efficient to cut this tool off at the root rather than wait for the multitude of inevitable frauds that will result from their further use. Much of the harm created by fake reviews is impossible to unwind or address once they have entered the stream of commerce. Holding Rytr accountable for knowingly providing the means to create such reviews is therefore justified.

One of the most harmful impacts of fake reviews is to steal business from companies that do not rely on or solicit fake reviews to bolster their own business or disparage others. The Commission has discussed these competitive harms in this Complaint and in its rule combating fake reviews. Indeed, small businesses supported the FTC's efforts to regulate this conduct for this exact reason. Commissioner Holyoak takes the position that there may be some legitimate consumer who is incentivized to write a review because this technology has made it easier and therefore provides a countervailing benefit to competition that should be evaluated in an analysis of unfairness. However, even if this is true, this argument overlooks the facts alleged in the Complaint about the tens of thousands of fake reviews that would easily drown out any such genuine, individual consumer reviews. In reality, it takes much fewer than thousands of reviews to impede competition. One study demonstrated that it only takes 50 fake reviews to surpass a competitor in terms of visibility. The entire purpose of Rytr's scalable design is to flood consumers with a manufactured perception of a particular business or product through these fake

reviews, preclude consumers from seeing legitimate reviews, and steer business away from honest competitors.

Finally, the Commission should not hesitate to bring enforcement actions against technology that is used to violate the FTC Act, regardless of how "innovative" it may be. The Commission has made clear that AI technologies are covered by existing law, and that "claims of innovation must not be cover for lawbreaking." The past informs the present and the future, and there are many instances that demonstrate the harm of "innovative" products. For example, the reckless mortgages that led to the foreclosure crisis were an "innovation" whose risks were largely ignored by regulators, even though they were apparent to many consumer advocates. It took years before defaults exploded to the level that they were viewed with concern and by then it was too late. Similarly, the FTC's enforcement action against Five Star Auto targeted a company who claimed to have developed an "innovative leasing concept" that allowed consumers to drive "their dream vehicle" and earn substantial income, but it amounted to nothing more than a classic pyramid scheme. ¹²

II. The Commission Should Adopt More Comprehensive Remedies to Address Rising Generative AI Harms, Both in This Case and Moving Forward

We commend the Commission for addressing the unlawful deployment and use of generative AI tools, but urge the Commission to strengthen the remedies applied in this case and in future cases. Rather than focusing on the stated use cases of generative AI systems, the Commission should pursue remedies that meaningfully limit the potential for those systems to be used for unfair, deceptive, and otherwise unlawful purposes.

While the elimination of Rytr's "review" use case reduces the likelihood that users will apply the tool to generate fake reviews, users can still easily prompt Rytr to generate such reviews by using remaining "use cases," including but not limited to "Quora Answer" (see **Appendix A** below).

In addition to the "Ban on Review or Testimonial Generation Services" included in the Consent Order, ¹³ we recommend that the Commission require Rytr to enact moderation practices that restrict output when users submit prompts that are clearly written to facilitate the practice of bulk review generation.

Users, regardless of who they are and whether they have an account, can also generate fake review content, including reviews generated to impersonate a government official or celebrity, on many other popular general purpose chatbot systems.

To illustrate the breadth of the issue of inadequate moderation from the makers of the most popular generative AI products on the market, several appendices are attached to this letter. As shown, several of the most popular general-purpose AI chatbots (OpenAI's ChatGPT, Anthropic's Claude, Meta AI, and PerplexityAI – **See Appendices B-E**), will produce seemingly unlimited numbers of fake reviews and even write these reviews from the perspective of popular celebrities when prompted. There are apparently few if any limits on outputs, nor are there consistent or meaningful warnings about how such tools should or should not be used.

Companies take differing approaches to moderating how their tools output certain information, but one common approach is to have a "blocklist." When a user employs a prompt on the blocklist, the chatbot system either says the system cannot generate a response or has a prewritten message redirecting users. ¹⁴ However, the reliability of such blocklists is inconsistent and often does not match a platform's stated terms of service.

The Commission should impose responsibility on platforms like Rytr to more proactively and directly limit the foreseeable (and even intended) use of generative AI tools for unfair, deceptive, or otherwise unlawful purposes.

III. Conclusion

CFA, EPIC, and NCL commend the Commission for bringing this enforcement action against Rytr and addressing the growing problem of widely available generative AI systems that enable and turbocharge fraudulent or otherwise unfair and deceptive acts. We particularly commend the Commission for addressing a root cause of fake review creation rather than simply one entity that used it, an important and appropriate use of means & instrumentalities liability. We also recommend that, in both the Rytr case and moving forward, the Commission apply stronger remedies such as requiring the company offering a content generation tool to more proactively block or limit outputs when a given prompt is clearly being used to break the law.


