Dear Administrator Revesz:

Several rulemakings are currently under review by OIRA that will significantly improve public safety on our Nation's roads. These rulemakings must be completed promptly, or lives will needlessly be lost.¹

In 2022, an average of 116 people were killed every day on roads in the U.S., totaling just over 42,500 fatalities.² An additional 2.38 million people were injured.³ This represents a 29 percent increase in deaths in just a decade.⁴ Early projections for 2023 traffic fatalities remain at a similar historic high level; nearly 41,000 people are estimated to have died that year.⁵

The financial impact of motor vehicle crashes on our economy and our families is staggering. The total value of societal harm from motor vehicle crashes in 2019 was nearly \$1.4 trillion.⁶

Our organizations and companies have been at the forefront of furthering proven technologies to reduce this fatality and injury toll. The National Highway Traffic Safety Administration has estimated that between 1960 and 2012, over 600,000 lives have been saved by motor vehicle safety technologies and associated federal safety standards.⁷

Few actions can be taken at this juncture by this Administration that will be more impactful than promulgating these lifesaving rulemakings. We urge you to bring them over the finish line.
